A (Very) Short History of RTK GPS

October 1995 -

- j) Membership: Stanton J. Abell, Jr.—no report, see Secretary Report: Active Membership role. Stan wondered why his name was still on this list. President Jones questioned what the Membership Committee's purpose was; he will talk with Stan.
- k) News Letter Lines & Points: New editor, Linda Abell and new assistant editor, Vickie Hudson. President Jones said there will be an issue out in 2-3 weeks.
- I) Nominations & Elections: Dennis Dawson, no report needed, annual meeting only. Marlowe said a teller needs to be appointed early on. 

- ii) History from each Chapter (to Herb Stoughton for inclusion in PLSW handbooks)
 - iii) Chapter expenditures reports
- b) PLSW membership includes 71 associate, 70 honorary, 2 life, 165 members, 9 special, 11 student, and 4 sustaining members.
 - 9) Treasurer's Report (Enclosure No. 6)

- 10) 2007 Budget: (see Enclosure No. 6)
- a) Marlowe reviewed the budget. He asked for questions on actual expenses and revenues. In the last Board of Directors meeting the budget was approved. There was a about a \$3000 deficit. The budget allows for an expected increase to the dues of about 7%. The motion approving the budget at the last Board of Direcor's meeting included moving money from the seminar fund into the general fund. This isn't needed. There is a reserve in the general fund. One of the reasons for the deficit was the increase

for Lines and Points budget in anticipation of a solution this year and an expected increase of \$1500 in that budget item. The 2007 budget will reflect an amount of \$2925 from the general fund reserves to balance the budget.

- b) New business item: How much do we want to have in our reserves? Marlowe suggested we may want to move monies into the scholarship fund. Monies are all collecting interest except the limited amounts in the checking account.
- c) Lloyd Baker mentioned that you lose 2.5% in savings because of inflation. He suggested investing in silver. Marlowe asked that any investment suggestions be addressed to Jon Anderson and the investment committee. PLSW's past strategy was to use mostly CD's at 4.5-5%. To get a better return on our investment, 18-20% was moved into equity funds. There is not a report on how the equity investments are doing because the money was only invested 30 days before. Dain Rauscher is choosing to invest in conservative equities. Next week, Marlowe is transfering approximately \$12,000 from the checking account to the Dain Rauscher investment account.
- d) Motion made to approve Treasurer's report by Lloyd Baker, seconded by Cotton Jones, motion was carried.
 - 11) Committee Reports:
- a) Audit Finance (Don Davis): The weather held Don in Casper, since the roads were closed to Sheridan. He was not there at the beginning, but after he came he reported. He had reconciled the bank statements with the general ledger. Everything appears to be in order and good shape. He asked for questions? There were none.
 - b) By-Laws (Alan Cormier): no report.
 - c) Convention (correction Cevin Imus): no report.
- d) Education (Bill Fehringer): no report. Marlowe indicated that the 2007 Fall Technical Session would be toward the end of October. Dates will be provided in the future.
 - e) History (Herbert W. Stoughton): no report.
- Legislative (John A. Steil): John provided a hand out which gave information on how to track potential bills in the Legislature. He reported the following bills which may affecting surveying: House bill No.8 - Fire District Boundaries: Fire Districts would be allowed to adjust boundaries if in agreement between two districts. House bill No. 10 – Subdivision Act: Would change 35 acre exemption to 100 acre exemption. Defeated in committee. House Bill No. 11 – Family Exemption: This bill seeks to change the one (1) year holding period of a property deeded to five (5) years before it could be transfered. The bill has been amended to a holding period of two (2) years. House bill No. 57 – Municipal Annexation: this would allow cities to annex property that does not touch the city or town. Defeated in committee. House Bill No. 124 – Eminent Domain bill. Very boggled up, not sure how it will end up. House Bill No. 160 - Subdivision Permit: subdivider would have to form a Home Owners Association. John read this bill to the members. This bill is going well. House Bill No. 277 – Surveyors and Engineers law: It would change the word "registered" to "licensing" and would renumber some of the sections. Senate file No. 42: This bill deals with vacation of Streets within Cities and Towns. It mostly renumbers sections. Senate file No. 28: State



Engineer rule making authority may adopt necessary rules that are necessary to implement articles and other duties by law. Scott Scherbel asked about House Bill No. 277. He understood that it also included changing licensing requirement to 4 year after 2013, and the composition of the board and the changes required. Ken Schramm added that during the November Board of Directors meeting they talked about the sunset date of education. The university had conflicts trying to change it to 4 years, so the Board of Directors agreed to push the sunset deadline to 2017 to allow some things to transpire. After the changes were made the bill was sent to the sponsor, the sponsor changed the dates back to the original 2013, Stan Abell and Pete Hutchison were staying in Cheyenne for the hearing to change them back.

- g) Manual of Professional Practice (Don Oakley and George Dale): Marlowe brought up his discussion with Cevin. The update is done and in CD form. PLSW's logo could be put on it. It could be used before Trigstar to spur interest. There is \$1000 fee. Fee includes a copy for all high schools. Marlowe said the idea would be discussed in Board of Directors meeting under new business.
- ii) Surveying instrument, a solar transit, is being donated to the state museum in Cheyenne. Larry is working on getting a history on the original surveyor. Rick said he had information on the history, and gave a brief outline about Clyde W. Atherly, one of the first registered in Wyoming. Suggested he get information to Larry Perry as soon as possible.
- n) S.O.S. [Corner Record Honorarium] (Paul Reid): This year's competition was on the back table.
- o) Scholarship (Scott A. Scherbel): \$3000 (\$1000 per semester) scholarships were given to James Jacobs and Bryan Hunt. Bryan is still at ISU. There is money available if others apply.
- p) Standards, Ethics & Professional Practice (Roy Holm, President, Northwest Chapter): no report.

- q) Trig-Star (Joel T. Ebner): Marlowe summarized the report. Just getting started with 2007 competition. Call Marlowe or Joel if you want to set up a local competition.
- r) Allen Mace Memorial Scholarship Raffle (Chris D. Hamilton): Sending out invitation to venders to send in donations. Marlowe gave a report during treasurer's report: \$1810.00 in direct contribution, \$1000 out of raffle, \$820 out of Casino Night.
- s) Investment Committee (Jon Anderson): Board of Directors through the direction of the chapters voted to invest up to 20% of money in money markets and in CD's into equity funds. Overview was given. Jan. 1, 2006 balance \$75,775.29 and December 31, 2006 balance \$79,172.18, net gain \$3397.89 which represents a 4.5% increase. He reviewed where assets were allocated Jan. 1, 2006 and then in December 31, 2006, 95% in cash and money market with 5% in equities and 82% in cash and money market with 18% in equities respectively. Interest return rate on CD's and fixed investment both increased from a range of 3.1 and 4.5% to a range of 4.6% and 5.25%. Recommended by Dain Rauscher to invest in Value Line Target 25 portfolio. Invested \$5,000.00 in November 2006 so not sure how it will do, but it has been an average annual return of 13.24% for past three (3) years. Also invested \$5,000.00 in the Target VIP Portfolio with average annual return of 10.07% for past three (3) years. These are both conservative investments. In regards to Loyd's comment on Silver, there are good returns, but he did not feel that it is within their charge as the responsible investor to invest in commodities. Asked for questions. No questions asked.
- t) Website Committee (Will Dolinar/Craig Davis): Trying to rebuild website. Will Dolinar had a few questions. Wondered what the official colors are? Rick Hudson indicated that the official colors are gold, red and white. Marlowe has all electronic versions of emblem. Western Federation of Professional Surveyors "West Fed" Report

West Fed has had 4 meetings since the demise and resurrection of Lines and Points. Its biennial convention was held in April at the Rancho Bernardo Inn co-hosted with the California Land Surveyors Association Annual conference. As I glean information from our meeting minutes I'll just give blips on the highlights and items deemed important in a chronological order.

Alaska has adopted mandatory continuing education legislation. Pat Tami, ex West Fed delegate and ex California Land Surveyors Association Past President was appointed by Governor Arnold Schwarzenegger as the Land Surveyor Member of the Board of Professional Engineers and Land Surveyors. California Land Surveyors Association (CLSA) Board of Directors recognizes that the greatest challenge facing our profession is the dwindling number of land surveyors. CLSA is addressing the issue in two ways. First is through an aggressive recruitment and public awareness campaign. This includes the seven minute DVD that CLSA produced as well as a new website, www.surveypath.org and printed material that will be sent to every high school math teacher in California. And second, is by providing education and resources to LSIT's to help increase the number of people passing the exam. The DVD was presented to each state association and a program has been setup for each state association to utilize it in promoting Land Surveying. Idaho (ISPLS) has set calibration baselines in Idaho Falls, Pocatello and Twin Falls and are now published and available on the NGS website. Montana delegate Dick Smith has been in contact with a librarian and curator of the National Railroad Museum in Sacramento CA. West Fed is looking into finding out what information they have "in a lot of field books" and if there is a need to archive and index them. Idaho delegate Dave Short reported that Idaho State University has received ABET certification for their 4 year degree surveying program. Montana Association of Registered Land Surveyors (MARLS) Board of Directors presented enthusiastic support for a multi-state conference in Salt Lake City for 2009. Nevada Association of Land Surveyors (NALS) now has a 4 year degree program at Great Basin College in Elko, Nevada. All surveying classes are now offered via Internet or Interactive video. Nevada Board of Directors has expressed interest in hosting the 2009 WFPS conference with Idaho and Utah. Utah Department of Transportation is working on setting up a state wide RTK GPS system. There were three sites and states that submitted proposals to the Conference Committee 2009. Upon vote by the Board of Directors the sites of Reno and Salt Lake City were selected for further consideration. Elected officials for the next term were as follows: Chairman, Dick Smith; Chairman-Elect, Ray Mathe; Secretary-Treasurer, Harold Baldwin. WFPS voted to send their Chairman and Chairman-Elect to all NSPS meetings. WFPS approved a donation of \$1,500 towards the creation of a brochure for the promotion of the David Thompson Traveling Exhibit. Scholarships totaling \$7,200 were awarded to 4 students enrolled in a 4 year Baccalaureate Degree programs for the Fall 2007/Spring 2008 academic year. The next meeting is set for September 15 in Las Vegas.

REPRINTED MAP SOURCES OF SNAKE RIVER

SNAKE RIVER EXPEDITION – JAMES STEVENSON, DIRECTOR

The Northwest Chapter has reprinted, from an old (perhaps first printing) lithograph found in a cabin west of Cody, the map of the Hayden - Stevenson expedition and survey of Jackson Hole, Yellowstone National Park and surrounding vicinity. The map shows the campsites of the expedition, from July 12th, 1872, at Fort Hall, Idaho Territory, up the Snake River, into Yellowstone, and returning to Fort Hall on October 11th.

The reprint measures approximately 28 inches by 29 inches overall, black printing on white background, and is printed on heavy photographic paper.

The map is representative of the cartographic style of the time and uses shading to depict mountain ranges, water lining on lakes and artistic profiles of various ranges including the Tetons.

A 39-page excerpt from "Great Surveys of the American West", by Richard A. Bartlett, published by University of Oklahoma Press, is to be included with the map (reprint permission pending) and details the progress of the expedition.

Herb's Corner

The editor, Ms. Linda Abell, has asked me to write a column on surveying issues, which have been brought to my attention. The editor's charge was to write a column addressing professional surveying issues and concerns. Therefore, I ask you, the reader, to submit items which you might like to see addressed. These items can be "professional", ethical, statutory/legal, or technical. If no issues are suggested, then the reader is placed on notice. I shall then take the liberty to address a personal concern. In 198788, I served as PLSW President (198788). As some of you know, between 1996 and 2003, I was elected to serve as the PLSW SecretaryTreasurer. Through the years, I have had the opportunity to be a member of several PLSW standing committees.

Since I have no suggestions for this first column, I have chosen the topic communication.

PROFESSIONAL COMMUNICATION

Communication is the ability to impart information and knowledge employing speech or writing. Since infancy, we have been exposed to learning to communicate. Unfortunately, in this writer's opinion, the formal tutorial process has been inadequate. In the primary and secondary education arenas the process has been to develop creative writing expertise and occasional factual reports. In surveying, communication is the most important skill/attribute required. Instructions must be delivered; reports must be prepared; technical analyses are required; performance reports, legal analyses, and oral presentations must be written and orally presented; and testimony must be delivered.

The "rules" required in each of these areas of communication


are very precise, and require the author to understand that each type of presentation has very specific applications.

In surveying and engineering, the expository style of writing does not satisfy the requirements of professional communication. First; precise wording and technical terminology are required. Technical terms must be specifically defined or understood by all readers/listeners. Second; failure to properly communicate can result in serious consequences in legal arenas. Numerous legal matters have been settled based upon "illdefined" statements. Third; the use of terminology and wording must satisfy the legal rhetoric. Legal writings are couched in historic tradition and prose. The apparent stilted style appearing in affidavits, contracts, deeds for easements and real property, legal pleadings, and rendered decisions are predicated upon centuries of writing and editing. Fourth; while contracts and specifications are considered legal documents (rightly so), the "boiler plate" appearing at the beginning and end of these documents is written by legal staff and attorneys. The technical aspects about the procurement of instrumentation and equipment or services and the description of the criteria for evaluation and assessment of performance are the domain of the surveyor and engineer. Fifth; writing fair and impartial personnel performance documents and the subsequent impartial evaluation of the individual's performance are critical. In recent history, the amount of litigation addressing these issues has increased many fold. In a significant number of these cases, the legal arguments addressed either the preparation of the performance requirements or the method of evaluation and lack of proper documentation of "failure" by a supervisor to satisfy the minimum

personnel performance requirements. Sixth; the writer has failed to sufficiently document technical reports of performance, justification for a specific course of action, and concise description of a professional/technical activity.

Another aspect of good communication is the in depth understanding of the technical aspects of communication. The author must be educated in numerous aspects of communication. These aspects do not have a hierarchy of importance. All aspects are equally important and must be equally addressed. The elements of technical documents address the issue of the form of the report. The minimal elements are: sections; headings; introduction (purpose and background); work plan; qualifications and experience; conclusion; recommendations; and appendices. The second issue is to understand ethical and legal considerations. This includes documenting sources; understanding what is common knowledge; ethical responsibilities; and legal responsibilities. The third issue is grammar and punctuation. The identified elements are understanding the parts of speech; construction of sentences; mechanics of writing; and punctuation. The fourth issue addresses designing textual and graphic elements. Included is this area are the topics of document design; layout of the document; format; tables; and graphics. The sixth issue addresses the mechanics of writing drafts and addressing quality control checks. The writer must understand the characteristics of effective technical communication; role of outlines and "rough" drafts' editing; and peer reviews.

There are numerous types of technical documents include letters (business and social); memorandi (formal and memorandum for record); incident and progress reports; trip reports; proposals; instructional manuals; and specifications. All these documents play significant roles in professional practice. One document, the trip report, is not frequently employed in private practice.

However, I assure the reader that this document can have importance in short and long range project planning. This writer has employed the trip report to not only report the facts pertaining to the official trip, but to report any note worthy matters which occurred and were not related to the official purpose of the trip. A number of years ago, this writer attended an international professional meeting. The writer's assignment was to present a technical paper. During the conference the writer had the opportunity to inspect the exhibits. During this conference a number of new instruments were introduced, which had not been previously advertised. The trip report stated the existence of this new technology. Subsequently, the organization purchased several units, which were needed to improve the organization's technical capabilities.

Another aspect of communication, which is relatively new, is electronic communication. The two areas are electronic mail (e.mail) and websites. While these areas have gained prominence, they have not utilized the etiquette of formal communication. The website has not been a forum of formal communication. The sites are a mass media instrument to attract a potential readers/customers. The e.mail has gained wide acceptance as a means of personal communication. However, the grammarian will be driven to drink with the total lack of writing and grammatical etiquette. The rules for punctuation, spelling, editing/proof reading, and capitalization are literally nonexistent! Personally, when I have to employ e.mail, and am communicating, I employ the social or business letter format,

depending upon the nature of the communication and my interaction with the recipient. Remember, the e.mail may be the first interaction, and the ageold rule "first encounters are a lasting image about you socially and professionally".

The presentation of information can have significant consequences. When the audience s a room full of people, then the oral presentation and the PowerPoint are the norm. For both approaches, the presenter must carefully prepare the presentation. Private rehearsing helps presenters to gain confidence and appear at ease before audiences. Scientific and technical report writing is considered the most loathsome professional activity. It need not be so detested. A fundamentally well written report is the "best seller" of you point of view, which is the purpose of your effort. If the writer frequently prepares reports for various subjects, then the writer should spend some time in designing and formatting reports.

Other types of written communication include describing and evaluating human performance elements, meeting agendas, and meeting minutes. Each of these types of documents utilize very unique attributes, style, and format. Remember, all these documents must be carefully scripted, because they could be exhibits and evidence in subsequent litigation.

These are a few thoughts concerning communication. To be a good communicator requires patience, understanding, and perseverance. Novices can find fundamental technical writing courses and works shops at most local post secondary academic institutions. In almost every community college, the perspective student will find at least one technical (technical report) writing course available. I some institutions, advanced (upper division) technical communication courses are offered.

Remember, the successful communicator is the individual who addresses the task with a positive attitude.

Survey Tech Program graduates 14 from Northwest

Professions experiencing work shortages can ease the deficit with a simple partnership.

"If you have a shortage we'd like to work with you," assistant director of the Center for Training and Development Marla Muscio said.

Recently 14 students graduated from the Northwest College Center for Training and Development (CFTD) Survey Tech Program. However, the course wouldn't have been possible without



a partnership between the Northwest College CFTD and the Northwest Chapter of the Professional Land Surveyors of Wyoming.

Professional surveyors taught as instructors and brought in state of the art

equipment for the students to use.

"We developed a curriculum to address skills needed for an entry level position," Muscio said. "Without the partnership we couldn't have afforded the equipment and they wouldn't have got hands on training."

Having professionals teach the classes gives them a chance to see prospective employees and find people who would be a good fit for their business. "It's a win-win situation," Muscio said. "They get a good lead on matching up a good quality person with a job."

Muscio said it's important for any professionals to become involved in shaping the program to make sure it suits their needs.

"We need their experience," Muscio said. "No one knows what is needed better than the people on the job right now."

She said the survey program is a good example of how quality workers can be produced in a given field. In the past two years the program has produced 41 people fully trained in entry level surveying. Nearly all have been placed in jobs helping ease a

shortage in the survey profession.

"They have all left with employable, marketable skills," Musico said.

Grants are available and the center will work with industries to identify the needs of the group. They will

then come up with a curriculum and find funds to help develop the training needed.

"Wyoming has funding available," Muscio said. "We just need to indicate we're definitely in a partnership with an industry and their will be jobs available once they complete the training."


